

## PEPPERDINE'S SEXUAL MISCONDUCT POLICY AND RESOURCES

Pepperdine University views everyone (including all students, employees, vendors, and guests) as a person of infinite worth, created by God, deserving to be treated with dignity and respect. Thus, the University prohibits its students, employees, vendors, or guests from engaging in any form of Sexual Misconduct.

Sexual Misconduct includes:

- sex discrimination
- sexual harassment
- sexual assault
- domestic violence
- dating violence
- stalking

All members of the community should understand:

- 1) that Sexual Misconduct is illegal, contrary to Pepperdine's Code of Ethics, and in opposition to its Christian mission;
- 2) the basic definitions and dynamics involved in each form of misconduct;
- 3) that there are people at the University prepared to receive reports from victims; and
- 4) that there are resources available to help support victims.
