

MBA Pathways Course Waiver

A minimum grade of "B" is required in each BSM course for which the equivalent MBA core course is waived through the MBA Pathways Program. Students who have not earned a minimum grade of "B" in the BSM course will be required to complete the equivalent MBA core course.

The units will be deducted from the normal 52 MBA minimum units required for the MBA degree based on the GPA in the BSM program. The units waived do not need to be completed in the MBA program.

3.3 - 3.39 GPA: waive up to 16 units.

3.2 - 3.29 GPA: waive up to 12 units.

3.1 - 3.19 GPA: waive up to 8 units.
