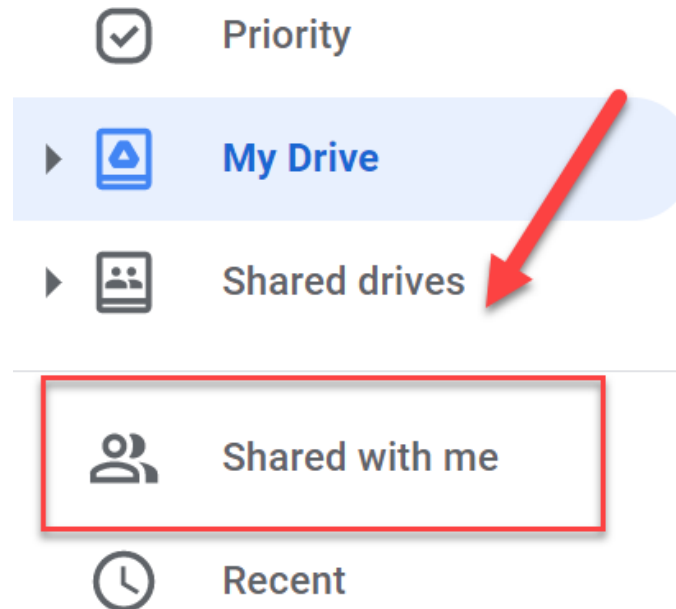

## Approving Contracts

Want to make sure you get paid on time? Full time contracts and supplemental payments (i.e. overload) require your electronic approval. Please review the steps below so you can sign contracts with ease and get paid on time.

\*NOTE: AY 2022-2023 contracts are currently in process. Faculty can expect next year's contracts to be sent out for electronic signatures towards the beginning of summer term.

**Step 1: Open the contract in Google Chrome**, this is the best browser as it allows the full contract to be seen and read.

**Step 2: Sign the contract and hit "done"** or it is not considered completed.  
(Reminders will continue to be sent if the "done" button is not hit)

*Once complete, click "Apply Signature" to eSign the contract, and click "Done" to exit.*

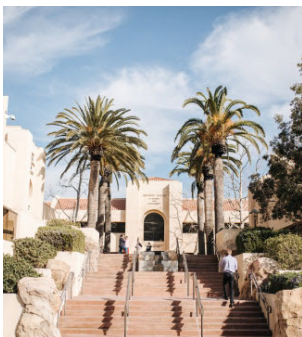

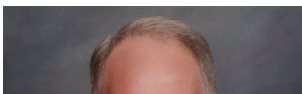
