Next, under Personal Details, select "Education" or "Addresses"









G. Louis Graziadio III, son of our benefactor George L. Graziadio Jr. passed away peacefully on Monday, October 17, 2022. Many of you remember him as an engaging storyteller, masterfully bringing the past to bear in the present with stories of his parents, George and Reva.

While he charted his own course to business success,

he embodied the same entrepreneurial spirit as his father. Motivated by a promise he made to his father to sustain the family's support for Pepperdine, his engagement with the business school was never greater than in this last year.

Louis Graziadio was the President and Chief Executive Officer of Second Southern Corp., the managing partner of Ginarra Partners, L.L.C., a closely-held California company involved in a wide range of investments and business ventures, and a member of the Graziadio Board.
