### ADVANCE ASSIGNMENTS FOR INTENSIVE COURSES

### RESCHEDULING EXAMS

While most Straus classes will require a final paper instead of a final exam, it is important for everyone to be aware of the exam rescheduling policy in the event you enroll in one or more classes with a final exam. Students may not petition to reschedule a final exam unless two final exams are to be taken on the same day. Therefore, it is important for you to pay attention to the final exam schedule when you are selecting your courses. Petitions to change one of two exams scheduled for the same day must be filed by the seventh week of classes. ### NEW ADJUNCT FACULTY MEMBERS

**Darryl Darden**- Lieutenant Colonel Darden honorably served the United States Army and National Guard for 33 years. During his service he was involved in several combat operations overseas as an Infantry Commander. He received several citations during Operation Desert Storm to include the Bronze Star. He developed the Army Diversity Program communication strategy. LTC Darden launched a well- received program of professional development courses, which focus on team building using diversity and capitalizing on team member individuality. He was the Executive Director of the Armed Forces Network, Seoul Korea where he managed nine media networks. Since retirement LTC Darden has performed over 500 family law and civil mediations in San Bernardino Superior court. He has mediated over 100 employment cases while serving Department of Fair Employment and Housing in downtown Los Angeles. As a County Superior Court Appointed Mediator he has successfully settled over 200 small claims, limited and unlimited jurisdiction cases. LTC Darden is a formally trained Ombudsman. He performs pastoral family/marriage counseling and mediation throughout California.

**Stacie Feldman Hausner** is a mediator who works with individuals and businesses. She has worked extensively for the Los Angeles Superior Court, Department of Consumer and Business Affairs, the Department of Fair Employment and Housing, and the Center for Conflict Resolution, mediating commercial, landlord-tenant, personal injury, discrimination, contract and employment disputes. She also has a private mediation practice and is a member of the Southern California Mediation Association. Prior to becoming a mediator, she worked as an attorney representing both plaintiffs and defendants in a commercial litigation and personal injury practice. She obtained her JD in 1996 from Boston University School of Law, where she graduated magna cum laude and served as Executive Editor of the Law Review. She also has received her LLM in Dispute Resolution from the Straus Institute at Pepperdine University School of Law.
