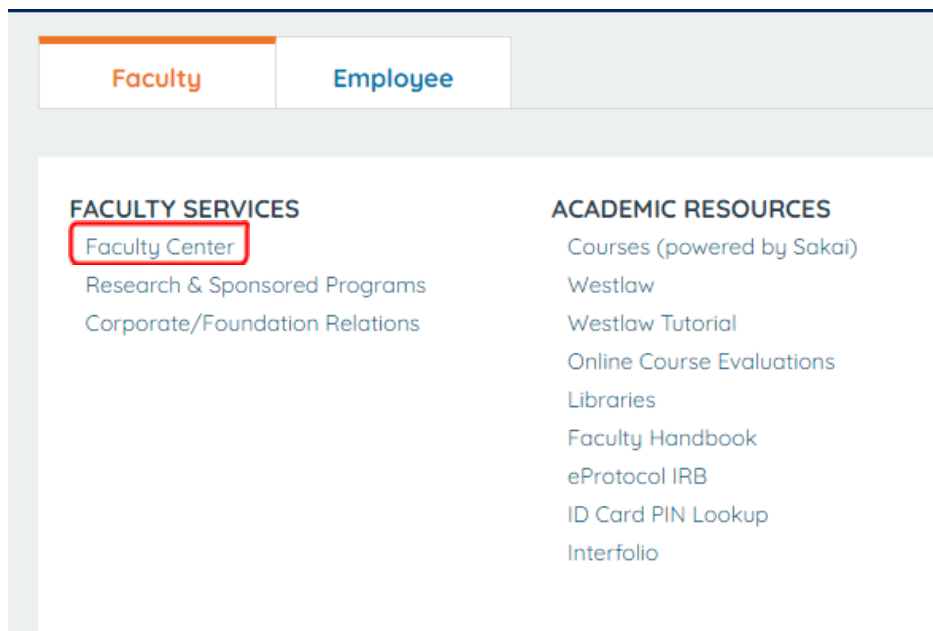


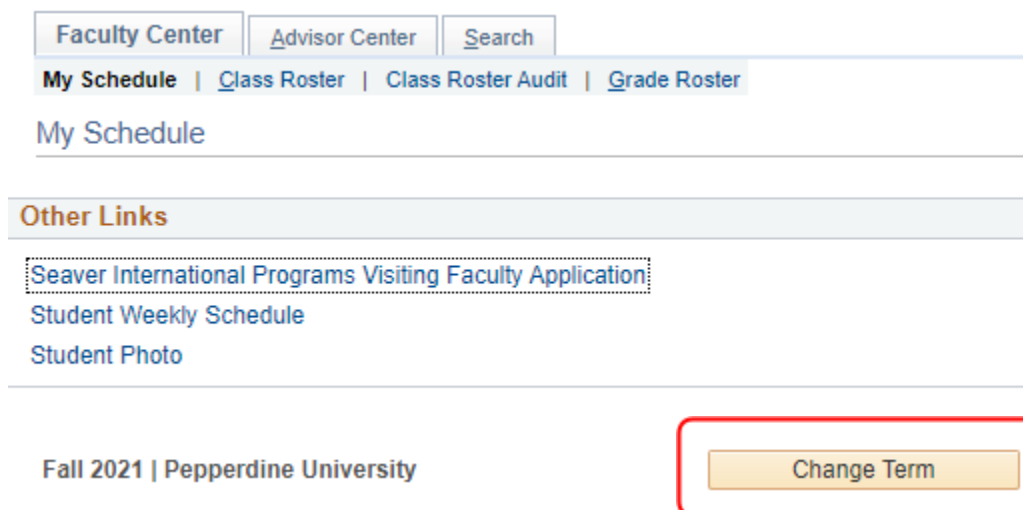
Submitting Final Grades in WaveNet

This guide is to assist you on how to submit the finals grades into your Faculty Center in WaveNet.

1. Login to WaveNet. Select Faculty Center on the left under Faculty Services

5. Enter your grades, scroll to the top of the page, and select from the drop-down menu, **“Ready for Review.”** Next, scroll to the bottom of the page and click **Save**. 7. You will receive an email from lawgrades@pepperdine.edu once the students' names have been exposed in the Grade Roster in WaveNet so that you may assign discretionary grades. After entering your discretionary grades, you must once again click **Save** at the bottom of the page to finalize your grades in WaveNet. Please ensure your discretionary grades are finalized as the "Official Grade" in the Grade Roster.
8. The grade distribution and required median must still be met, even after awarding discretionary points. Please use the grading formula to ensure the requirements are being met. If your grades are deviating from the recommended grade distribution, please provide an explanation via email to the Academic Dean. Please email lawgrades@pepperdine.edu once you have entered and saved your final grades.
9. Our office will notify the Academic Dean to approve your final grades. Once your grades have received approval, we will post the final grades for the class to view. The final grades only appear in the students' WaveNet Student Center and not on any other platforms used by Caruso Law. You and the students will be notified once final grades are posted.
