myself, my heirs, personal representatives or assignees, agree as follows:

# FINANCIAL REQUIREMENTS AND COMMITMENTS

- 1. I agree to pay the fees published by Pepperdine in the Seaver College 2026-2027
  Academic Catalog for this Program. I understand that the current published fees are likely to increase. However, if the tuition or food and housing charge increases by more than ten (10) percent over the current published price, I may be released from the terms and conditions of this Contract if I provide written notice to international.programs@pepperdine.edu within 30 days of the publication of the new price. I understand that there are Program-specific costs over and above the International Programs charge that I must pay, including, but not limited to, the fees listed in the Seaver College Catalog (<a href="https://seaver.pepperdine.edu/academics/catalog/">https://seaver.pepperdine.edu/academics/catalog/</a>) and on the International Programs website (<a href="https://community.pepperdine.edu/seaver/internationalprograms/resources/costs.htm">https://community.pepperdine.edu/seaver/internationalprograms/resources/costs.htm</a>).
- 2. I acknowledge that I will be billed for a global health fee for the time I am outside of the United States which provides me with international healthcare services (fees for the 2025-2026 school year are \$420 per semester for abroad locations and \$60 per semester for the DC program; see the International Programs website (https://community.pepperdine.edu/seaver/internationalprograms/resources/costs.htm) for updated fees when they become available). According to University policy, all International Programs participants must hold a U.S.-based health insurance plan for the duration of their study away experience in the event that students return to the U.S. for planned or unplanned reasons. I acknowledge that I am responsible for and must be ready and immediately able to pay for my personal health care costs. I also understand that I may be required to pay additional local health fees to abide by local laws and/or for required immunizations for my Program. Resources regarding required vaccinations and immunizations are available on the US Department of State website. I am responsible for any and all mandatory health costs.
- 3. I understand that I am responsible for arranging any financial aid to be received during the Program with the individuals, programs, and/or scholarships that contribute to my financial assistance. I have received financial aid advice from my financial aid advisor and am fully aware of the costs that will be incurred in my Program.
- 4. I have discussed the financial responsibilities for the Program with those providing me with financial assistance (parents/guardians/others).
- 5. I acknowledge that I will be responsible for paying all fees and costs associated with

early withdrawal and termination of this agreement (minimum of \$1,000), if applicable. A schedule of fees is detailed below under the Withdrawal/Ineligibility Policy.

### PRE-DEPARTURE REQUIREMENTS AND RESPONSIBILITIES

- 6. I understand that important communication from the International Programs Office will be sent via Pepperdine student email or in the ViaTRM portal. It is my responsibility to check this email and ViaTRM portal several times per week and confirm that I do not have issues receiving or sending emails from/to International Programs email addresses or @via-trm.com. I understand I should keep notifications from ViaTRM active.
- 7. I understand that I cannot book flights for the Program until I am directed to do so by International Programs. I understand that I am required to book round trip flights through Pepperdine's chosen travel services company. I agree to abide by all other International Programs flight policies and procedures in the International Programs Student Handbook and in the International Programs Flight Policies Document: (https://docs.google.com/document/d/1mTbe0JZZ0k5VMf60yLV3XeGdedKMlxn2VZH5dW8PKQg/edit?usp=sharing). I understand that I am responsible for any and all travel expenses (i.e., flights, ground transportation, meals, and transfers) if I am removed from my program or if I withdraw mid-semester and need to travel back home. I understand that Pepperdine recommends purchasing travel insurance for my flight and personal belongings.
- 8. I am responsible for completing all required study abroad orientation and preparation requirements. I understand that I am required to attend all orientation sessions, complete all required orientation modules, and attend mandatory meetings such as preparation and visa workshops by the date communicated by the International Programs Office. I am also responsible for providing all required materials to the International Programs Office by the deadlines provided by the International Programs Office. I acknowledge that failure to complete any of these requirements may result in ineligibility, withdrawal fees, and dismissal from the Program.
- 9. I have created a course plan incorporating my proposed International Programs courses. I have met with my academic advisor and/or my major advisor and have determined that I am eligible to take 12-18 units for each term of my Program. I am also aware of any applicable prerequisite courses and any required courses I must take before and during the Program to meet the requirements of my major. I understand that I must be eligible to take at least the 152 level of any language required by my Program. I understand that I am only able to take the courses being offered in the Program and must maintain full-time student status each semester of my Program. I understand that changing my major after signing this agreement does not exempt me from Program requirements. I understand that all courses are subject to change based on course enrollment and faculty availability in my program. I understand that determining course requirements for graduation is my responsibility.
- 10. I acknowledge it is my responsibility to **complete a health clearance process**, which includes meeting with a healthcare professional between 45 and 90 days prior to the start of the Program and being cleared to participate in my Program and submitting the Health Clearance Form to International Programs at least 45 days prior to departure. I

acknowledge that I will provide the health provider who is reviewing my health clearance form with detailed information regarding my upcoming travel (study location, field trips, and personal trips) and will provide them with accurate and up-to-date personal health information in the health history form.

- 11. I acknowledge that I am strongly encouraged, but not required, to securely upload a copy of my health history form in ViaTRM. Regardless of whether I upload my health history form, I give my consent to the University to share my health history for medical or psychological treatment to healthcare service providers where I am unable, or it is impractical to provide such information for treatment myself. I acknowledge that I will travel with the original copy of my health history form in my Emergency Envelope in the event of a medical emergency.
- 12. If I am under the care of a mental health professional or medical provider that is caring for my chronic illness, I have discussed with them my plan to participate in the Program and have determined that such participation is appropriate. I understand that health services (including psychological services) are available while I study away, but such services may not be sufficient to address my specific healthcare needs. I understand that I am solely responsible for seeking out and paying for additional care that is not covered under Pepperdine's health services plan.
- 13. I am responsible for obtaining and paying for any necessary passport(s), which must be valid for at least 6 months after the program return date (or student planned return date if after the program end date), and/or visa and/or residency permit specific to the host country. If I am a non-United States passport holder, I am also required to independently obtain and pay for the necessary visas for the host country as well as for the Educational Field Trip locations by the deadline provided by International Programs. I acknowledge that it is also my responsibility to obtain and pay for any necessary visas required for independent travel destinations. I agree to provide electronic copies of my passport and any visas to the International Programs Office by the due dates specified by the International Programs Office. I understand that I may be required to obtain a second passport in order to apply for a visa in the event that my original passport is needed for personal travel, or in the event that I am studying abroad in another International Program at the time my passport is needed to apply for a visa.
- 14.I hereby **permit a representative from the International Programs office** at Pepperdine University **to appear on my behalf at a consulate or embassy to procure visas** or visa documents for my Program. This representative shall not be liable for any damages or loss that results from a judgment error that was made in good faith. This representative shall not be entitled to any compensation, during my lifetime or upon my death, for any services provided in this capacity. This permission shall be effective from this day until the conclusion of my Program.

## RESPONSIBILITIES/COMMITMENTS ONCE IN YOUR STUDY AWAY LOCATION

15. I agree to abide by all of the laws, rules, and regulations of the Program country and any countries I visit while attending the Program. I also agree to abide by all Pepperdine rules and policies including, but not limited to: my specific program's Program Manual, the International Programs Student Handbook (posted on the IP policies webpage

My failure to comply with these laws, regulations, rules and policies may result in disciplinary action, up to and including expulsion from Pepperdine.

- 16.I acknowledge that it is my responsibility to take every precaution to safeguard my health and personal belongings from damage or theft. Pepperdine will not be responsible for sickness, damage, or theft. I acknowledge that Pepperdine recommends that I never travel alone, particularly at night.

I understand that I am responsible for accurately and completely entering my travel information in Pepperdine's travel log system, as required by the University. I understand that failure to accurately and completely fill out the travel log according to the policy set forth in the International Programs Handbook and by the relevant program director may result in disciplinary action against the student.
- 18. I hereby give my consent to treatment in the event of a medical emergency, if at that time I am incapacitated and unable to consent to such treatment. I will be financially responsible for any and all costs of such treatment. I agree that I will not hold the University responsible for any claims resulting from medical treatment or lack thereof.
- 19.I hereby consent to International Programs contacting my parent(s), guardian(s), and/or the emergency contact(s) listed in connection with my University records with periodic communications regarding programs for which I have applied or signed a contract. In the event of an illness, emergency, or if I am missing, I consent to International Programs contacting and releasing medical information and other student information to my parent(s), guardian(s), and/or emergency contact(s). I understand that I am therefore responsible for keeping my emergency contact information accurate and current within my University records.
- 20. Pepperdine reserves the right to modify the program for any reason, including, but not limited to the comfort and protection of its students, or cancel the Program as may be required due to circumstances beyond the control of Pepperdine or to protect the health and safety of Program participants. Pepperdine will not be responsible for the cost of a student's personal leisure travel that is canceled due to modification or cancellation of the Program. This includes the student's personal travel expenses related to a location that is deemed unsafe by Pepperdine upon review of the U.S. Department of State and/or other travel risk advisories.

# ASSUMPTION OF RISK, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

- 21. I understand and acknowledge that the Program presents risks to me and my property, and that Pepperdine cannot guarantee my safety or the safety of my property. I understand and agree that the Program activities may be dangerous and may involve risks to personal safety and physical risks which can range from but are not limited to: minor injuries such as scratches, bruises, and sprains to catastrophic injuries, including paralysis and death. I understand and agree that the Program involves international travel and may involve unfamiliar or different terrain, customs, climate, food and drink, laws, social norms, sports practices, rules and regulations, communications, criminal and law enforcement activities, disability access, driving practices and road conditions, premises conditions and/or maintenance. Risks may also include: exposure to disease and virus outbreaks, inadequate health care, natural disasters, acts of God, war, civil unrest, terrorism, kidnapping and assault, physical violence, verbal abuse, sexual abuse, short and/or long term disability, loss of income and/or career and earning opportunities. Nonetheless, I acknowledge that my participation in the Program is voluntary and that I assume all risks, whether known or unknown.
- 22. To the fullest extent allowed by law, I release, waive, discharge, and covenant not to sue, Pepperdine University, its Board of Regents, employees, agents, attorneys or volunteers (collectively the "University") from all liability to me that may be caused by any act, failure to act or negligence by the University, myself, or any third party, the condition of the Program premises, Program travel, from the unavailability or inadequacy of emergency medical care, and from the use of my name and likeness as discussed in paragraph 24 below. I understand that I am waiving my rights to recover all damages from the University for any mental or physical injury (including death), social and economic loss, and damage to or loss of property, relating to or arising out of my participation in the Program.
- **23.I agree to indemnify and hold the University harmless from any and all claims**, actions, suits, judgments, costs, expenses, damages and liabilities, including attorney's fees, which in any way relate to or arise from my participation in the Program. If the University incurs any of these types of expenses, I agree to reimburse the University.
- 24. I hereby authorize the University and its associates or assignees, or anyone acting under its authority or permission, the irrevocable and unrestricted right and permission to: a) record my participation and appearance on a video tape, audio tape, photograph, digital, electronic or any other medium, b) use my name, likeness, voice and biographical material in connection with these recordings and c) use, reproduce, exhibit or distribute in any medium now known or later invented (e.g., print publications, videos, and Internet) these recordings in whole or in part for any purpose that the University, and those acting pursuant to its authority, deem appropriate, including promotional or advertising efforts. I waive any right that I may have to inspect or approve the finished product or products that may be used in connection therewith or the use to which it may be applied. I understand that all such recordings, in whatever medium, shall remain the property of the University and that I am not entitled to any compensation from the University for use of the recordings.

### WITHDRAWAL/INELIGIBILITY POLICY

- 25. In order to withdraw from the Program (regardless of whether I have withdrawn from Pepperdine through the Registrar's Office), I must complete the International Programs withdrawal process. Should I become ineligible in any of the ways listed below or by violating any provision of this agreement, I may be removed from the Program and withdrawal fees will apply (item 27 below).
  - By being placed on academic probation or by having a semester GPA below a 2.0 in any academic session preceding the start of or during my Program;
  - being placed on disciplinary probation, suspension, or expulsion;
  - withdrawing from Pepperdine;
  - having unresolved restrictions placed on registration for any reason;
  - having a past-due balance on my student account;
  - failing to complete a course prerequisite and/or language requirements; by not being cleared by a health professional to participate;
  - failing to enroll in a language course while abroad;
  - being unable to maintain full-time student status;
  - failing to obtain on a timely basis the required documents to attend a Program;
  - not participating in all pre-departure and in-program mandatory orientations and meetings;
  - failing to register by the applicable deadlines;
  - failing to obtain all necessary visas;
  - failing to meet the minimum class attendance requirements.
- 26. If I am suspended, dismissed, or expelled from Pepperdine while studying with International Programs, I understand and acknowledge that I must leave the Pepperdine facility within 24 hours after receiving the dismissal, suspension, or expulsion notice. I have the right to appeal said dismissal, suspension, or expulsion and may stay in University housing for an additional 24 hours until a decision is made, unless I have been placed on an interim restriction by the University. I understand that Pepperdine requires verification that my parent or legal guardian has been informed of my university status and departure from the program prior to departing the Pepperdine facility. I understand and acknowledge that this decision may also require me to leave the country immediately due to immigration status.
- 27. Timeframes, for withdrawal purposes, will be determined by the date on which my signed notice of intent to withdraw from the Program, or a notification that I have become ineligible to participate in the Program, is received by the International Programs Office in Malibu. All withdrawal fees will be immediately charged to my student account. (An optional appeal process is available for all withdrawal fees incurred above \$1,000 and the completed appeal is due to the International Programs Office no later than 45 calendar days from withdrawal/ineligibility). Once withdrawal charges are posted, I will have 60 calendar days before finance charges begin to accrue and I understand International Programs is unable to stop or remove finance charges that are posted to a student's account:
  - a. If I withdraw from or become ineligible to attend the Program prior to February 6, 2026 for Academic Year and Fall-only programs, or prior to July 6, 2026 for Spring-only programs, I will be responsible for the non-refundable and non-appealable \$1,000 withdrawal fee, regardless of my reason for withdrawal.

- b. If I withdraw from or become ineligible to attend the Program from February 6, 2026 through April 20, 2026 for Academic Year and Fall-only programs, or on or after July 6, 2025 through September 14, 2026 for Spring-only programs, I will be responsible for twenty (20) percent of the total International Program (IP) Charge (see "f" below for IP Charge).
- c. If I withdraw from or become ineligible to attend the Program on or after April 21, 2026 through June 18, 2026 for Academic Year and Fall-only programs, or on or after September 15, 2026 through November 13, 2026 for Spring-only programs, I will be responsible for forty (40) percent of the total International Program (IP) Charge (see "f" below for IP Charge).
- d. If I withdraw from or become ineligible to attend the Program on or after June 19, 2026 for Academic Year and Fall-only programs, or on or after November 14, 2026 for Spring-only programs, I will be responsible for fifty (50) percent of the International Program (IP) Charge (see "f" below for IP Charge), as stated in the Seaver College Academic Catalog.
- e. I understand that if I withdraw from or become ineligible to attend the Program, I forfeit any financial assistance which I had been awarded to attend the Program.
- f. Academic Year/Fall or Spring IP Charge: Includes housing, most meals, field excursions (including educational field trip or international studies tour), select transportation, and local orientations. 100% of the IP Charge in academic year 2025-2026 is \$12,990 (\$13,710 for Washington, D.C.).
