California residents are **REQUIRED** to go on the group flight. Students may petition to be exempt from the Group Flight if they live outside of California. For summer programs, flight exempt students will not receive any financial compensation/reimbursement. After March 1, a spot on the group flight cannot be assured.

I commit to be on the group flight. By marking this box...

- 1) I understand I will receive a ticket to depart from and return to LAX on the group flight.
- 2) If I am attending for the full academic year, I understand that my group flight will depart at the beginning of the Fall term, return at the end of the Spring term, and that a flight home between the semesters is not provided.

Changes to the return date only may be possible through Corniche Travel, Pepperdine's travel provider, but any deviation from the ticketed itinerary will be at the student's own cost, and will include both change fees and potential fare differences.

I petition to be exempt from the group flight. By marking this box...

- 1) If I am a summer program participant I understand that I will not receive any financial compensation/reimbursement.
- 2) If I am not a summer program participant, my IP fee will be reduced by \$1,040 (foreign programs), or \$500 (Washington DC).
- 3) I must submit my confirmed flight itinerary to the IP Office no later than 45 days prior to program departure.
- 4) I will arrange my own transportation to/from the airport and to/ from the program facility.
- 5) I understand there are no provisions for early arrival and agree to arrive on the same day as the group flight and check into program facilities during 9am-5pm business hours.

IMPORTANT NOTE FOR SUMMER PARTICIPANTS: Pepperdine University will be paying flight costs on behalf of Summer IP students. Per the terms of your contract, should you withdraw or become ineligible (and depending on the date), you can/will become responsible for the cost of these flights that have been purchased on your behalf. Flight costs range from \$890-\$2,500 depending on location.

My signature below confirms that I understand the conditions of this contract, the policies regarding my return flight, and that the group flight departs from LAX and returns to LAX without exception. On group flight tickets, change requests are not guaranteed, airport routing changes can never be made and a change in the return date will result in an airline-imposed non-group return fee. Further, I also understand that it is my responsibility to obtain all required visas/entry clearance permits as dictated by the program's host country. I understand that my passport must be current for at least 6 months after my return to the United States and failure to comply could result in denied entry on the airplane.
