TITLE IX AND SEXUAL MISCONDUCT

AT PEPPERDINE

Title IX is a federal law that prohibits discrimination on the basis of sex and prohibits specific types of sexual misconduct. Alleged incidents of sexual misconduct that occur on a Pepperdine campus or at a University-sanctioned event in the United States may fall under the jurisdiction of Title IX. The University will address allegations of incidents of sexual misconduct that fall outside of the jurisdiction of Title IX pursuant to its broad sexual misconduct policy. That policy prohibits students, employees, vendors, or guests from engaging in any form of sexual misconduct.

- Sexual harassment
- Sexual assault
- Domestic violence
- Dating violence
- Stalking
- Quid pro quo harassment
 - Opportunities or other gains are conditioned on submission to unwelcome sexual advances

If YOU Are Involved in an Alleged Sexual Misconduct Matter

If you are involved in an alleged sexual misconduct matter, you may receive help from a Title IX case manager, which can include supportive measures and navigating resources on and off campus. You may speak confidentially with a counselor at the Counseling Center. Involved parties may be assisted by an advisor of their choice at prehearing meetings, at hearing and appeal meetings, and at informal resolution meetings.

If YOU Experience Sexual Misconduct

If danger is imminent, call **911**, then Public Safety **310.506.4441**. Consider: getting immediate medical attention to address injuries, STIs, pregnancy, and to preserve evidence; seeking immediate professional support and post-crisis counseling; requesting supportive measures such as escort services, academic support, and housing accommodations; reporting options such as filing a formal sexual misconduct complaint through the Office of Title IX; filing a report with local law enforcement; civil litigation; and connecting with confidential resources such as the Counseling Center **310.506.4210**.

File a Report

If you have experienced sexual misconduct, you have the right to file a report with a number of authorities.
